#### 13. Other Documents

By signing this form, you undertake to provide:

- (i) on request, a copy of the most recent P60 (or its equivalent or evidence of the issuance of a P60) for each employee who operates a pitch as your employee;
- (ii) on request, a copy of a recent payslip or invoice for any employee or contractor who has worked on-course;
- (iii) on request, a print-out of the day's trade from the relevant betting exchange account used at each pitch on each day on which you use an employee or an Alternate Operator to operate the pitch(es);
- (iv) on request, a copy of your ledger showing the profit or loss on each such day; and
- (v) in accordance with clause 2.11 of Special Conditions E, such further documents and information as AGT may request from time to time.

**14. Declaration**

I, being the Licensee, agree to inform AGT immediately if there is any change to these circumstances including any updates to my Operating Licence.

I understand that all telephone calls to AGT's offices may be recorded.

I am aware that by clause 4.4 of the Racecourse Licence Agreement in use at most racecourses I have agreed to trade from the betting position allocated to the Licensee and agreed not to 'assign, transfer, sublet, charge, or otherwise dispose or part with or share possession or occupation or authorise any other person (except its employees) to use the whole or any part of the Betting Position.' I understand this means that I may not rent, sublet or share any betting position to/with another bookmaker or allow anyone else to trade from it on their own account or on any third party's account.

I undertake not to rent, sublet or share any betting position at any time and not otherwise to breach any term of clause 4.4 of any Racecourse Licence Agreement.

I understand that any Licensee who contravenes the terms of his, her or its Licence and/or is found to be involved in pitch renting may face any one or more of the following:

- (a) removal or suspension from the relevant racecourse;
- (b) forfeiture or suspension of the Racecourse Licence Agreement at the relevant racecourse; and
- (c) in conjunction with the relevant racecourse(s), AGT may rescind this registration which, in effect, removes the Licensee from all Badge Box lists.

I confirm that all equipment used on the racecourse is safe, fit for purpose and, where necessary, it has undergone relevant Health and Safety checks and Risk Assessments.

I declare that the above information is true and complete and that, as a condition of application, I agree to be bound by the terms of the Special Conditions E and the Position Allocation Policy. I understand that I am signing this form on behalf of all persons named on the Operating Licence and I agree that they are similarly bound by the above terms and conditions.
