### Bidding Form

This is the Bidding Form as referred to in the letter entitled 'Invitation to bid for betting positions on the Hill at Epsom Downs Racecourse' (the "**Letter**") published on the website [www.agt-ltd.co.uk](http://www.agt-ltd.co.uk) on behalf of Epsom Downs Racecourse Limited. Defined terms in this Bidding Form shall have the meaning given to them in the Letter.

If you wish to submit a bid or bids in accordance with the process detailed in the Letter, please complete this Bidding Form and return **by recorded delivery** to The Hill 2019, Administration of Gambling on Tracks Limited, 3a Kings Hall, St Ives Business Park, St Ives, Cambridgeshire, PE27 4WY by **no later than 29 March 2019**.

#### 1 Your First Option Bid:

1.1 By completing the table below you may bid for and operate any number of betting positions in any number of betting areas on the Bid Days up to a maximum of two (2) betting positions in any single betting area except for the Hillside Enclosure, Car Park 26 and Market/Old London Road betting areas where you may only bid in each betting area for one betting position.

Once submitted, your bid is deemed to be binding on you and may not be amended or rescinded in any way. Any sums bid by you will be deemed to be inclusive of VAT and bids will only be considered if they are for a sum equal to or in excess of the amount set out for each betting area in the table below in the column entitled 'Minimum bid'. Any sums bid must be in whole pounds. Please indicate your bid(s) below:
